The above Order, made on 18 December 2024, under section 119 of the Highways Act 1980, and section 53A(2) of the Wildlife and Countryside Act 1981, will divert part of Public Footpath No. 15, Oakley from point A on the Order map at SP63664-11692 south south west for 131m to point B at SP63645-11563 and from point E at SP63649-11517 south south west for 372m to point F at SP63547-11173 as shown by a bold continuous line, to a line running from point C at SP63674-11622 south west for 52m to point D at SP63640-11582, then south for 20m to point B at SP63645-11563 and from point E at SP63649-11517 south south west for 165m to point G at SP63615-11372, then south for 103m to point H at SP63590-11272, then south south west for 110m to point F at SP63547-11173 as shown by a bold broken line with a width of 3m throughout and will divert Public Footpath No. 16, Oakley from point I on the Order map at SP63752-11465 south for 693m to point J at SP63755-10787 as shown by a bold continuous line, to a line running from point I at SP63752-11465 south south east for 122m to point K at SP63766-11348, then south west for 129m to point L at SP63665-11267, then west for 75m to point H at SP63590-11272 as shown by a bold broken line with a width of 3m throughout, and with a 2m wide bridge at point H at SP63590-11272.

If the Order is sent to the Secretary of State for Environment, Food and Rural Affairs for confirmation any representations and objections which have not been withdrawn will be sent with the Order.
